


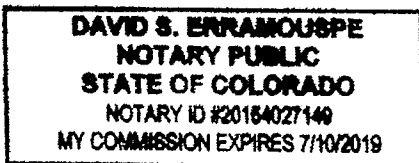

The deadline to submit a Self-Nomination and Acceptance form is the close of business on Friday, March 2, 2018. Earlier submittal is encouraged, as the deadline will not permit curing an insufficient form. Affidavit of Intent To Be A Write-In-Candidate forms must be submitted to the office of the DEO by the close of business on Thursday, March 1, 2018.
